1) Financial:

- a) Dark skies initiatives, about 10 lights left on the ranch that need to be dealt with, details can be found in the CCR's on what is acceptable.

- c) Coyotes on the ranch, board members will try to deal with issues and any homeowners in the area will be notified. It will be a controlled environment. DNR has been in discussion with Greg record on how we can deal with the issue. Pay attention out there, be safe.
- d) Dog barking issues, county allows four dogs per property. Nuisance clause in CCR's, board will follow them. Notify board if you have issues and board will manage. Please keep your dogs on your property and under control. Dogs cannot run the ranch if you see loose animals please call animal control so we can be sure all are safe.
- e) Respect your neighbors and be kind.
- f) If drones are over your property pleased contact the Sheriffs office.
- g) Thunder Ridge Airpark, had to pay attorneys to go over letter received about Bandanna HOA paying for the upkeep of the airpark.
- h) Getting bids for new cover for the front dumpsters.
